Requirements for the Report of Marriage of Filipinos Married in France and Monaco

- Report of Marriage Form four (4) completely filled-out and originally signed forms. Use black pen. Digital signatures are not allowed.
- Apostilled Acte de Mariage -original Acte de Mariage Copie Integral (Extrait de Mariage is insufficient) and three (3)
 photocopies:

- English Translation of Acte de Mariage Copie Integral (done by a licensed translator, no need to be apostilized) original and three photocopies.
- 4. Original and four photocopies of valid passport(s) of the spouses. (if for mailing no need to send the original passport/s)
- 5. If widowler, original and three photocopies of Marriage Certificate and Death Certificate issued by Philippine Statistics Authority (PSA).
- 6. If annulled or divorced, original and three photocopies of Marriage Certificate with Remarks issued by PSA.
- 7. If marriage is more than one year at the time of registration, personal appearance of applicants or one of the spouses and four original copies of Affidavit of Delayed Registration of Marriage

NOTE: * The person who execute an affidavit shall appear personally at the Philippine Embassy or nearest Honorary Consul and each affidavit must be in four (4) copies, each copy must be originally signed and with photocopy of the passport's data page of the person who executed an affidavit. Additional documents may be required upon assessment of the application, depending on the circumstances of the applicant/s.

Payments should be made either in the form of cash or cheque de banque payable to "Ambassade des Philippines". Payments made through credit card or personal checks are not accepted.

A **Negative Certification** is required for marriages <u>not registered for 10 years and over.</u> You may get a copy of it from the Philippine Statistics Authority (PSA). You have the option to obtain the negative certification online via https://www.psaserbilis.com.ph/

If to be sent by mail,

- Enclose a prepaid self-addressed registered return A4 size envelope (recommandé avec avis de réception) with your complete mailing address and record your <u>tracking number</u> since the Philippine Embassy is not liable for documents which have been mailed through La Poste. For the safety of your documents, we recommend using "enveloppe à bulles" or "pochette XS".
- Payments should be made in the form of **cheque de banque** payable to "Ambassade des Philippines". The Embassy does not accept payment for stamps and mailing services. Do not put cash in the envelope as the Embassy is not liable for possible loss.
- Please include your contact number so that we can reach you immediately.
- No need to send the original passport/s.
- Processing time of the documents begins only upon the complete receipt of the documents and payment. Delivery period is not included in the processing time. Please note that the Embassy will not process applications unless all of the following requirements are complied with.
- It is the applicant's responsibility to write their correct address. The Embassy is not liable for the loss/return of your documents by La Poste.
