**CONTRACT FOR THE ENGAGEMENT OF A VLOGGER ON THE PROJECT  
“RETRACING DR. RIZAL’S FOOTSTEPS IN FRANCE”**

**KNOW ALL MEN BY THESE PRESENTS:**

This Contract for the engagement of a vlogger for the project “Retracing Dr. Rizal’s Footsteps in France” as part of the commemoration of Dr. Jose P. Rizal’s birthday on 19 June 2021, executed and entered into on 3 June 2021 in France, by and between:

**The Embassy of the Republic of the Philippines in France**  
(First Party) with principal office address at 4 hameau de  
Boulainvilliers, 75016 Paris, France represented by the  
**Chargé d’Affaires, Aileen S. Mendiola-Rau,**

and

**Ms. Fideliz Apilado** (Second Party), with address at 1 allée  
Paul Langevin, 92700 Colombes, France.

**WITNESSETH:**

1. The First Party decided to engage the services of the second party to lead the project “Retracing Dr. Rizal’s Footsteps in France” hereinafter referred as “Dr. Rizal Vlog” as part of the commemoration of Dr. Rizal’s birthday on 19 June 2021. The Second Party is a known vlogger, social media influencer, and a stringer of the Philippine TV Channel.
2. Noting the previous collaborations between the First Party and the Second Party in the *Fiesta Filipinas* project held from December 2020 to May 2021 where the latter showed her active participation and support, and her competence in the promotion of Philippine culture in France, the Embassy selected Ms. Apilado as the suitable resource person to lead the Dr. Rizal Vlog.
3. The First Party shall provide the Second Party a copy of the book “Philippines France: Discovery, Rediscovery,” where the contents of the Dr. Rizal Vlog will be based, particularly in Part 2 of the book that extensively discusses Dr. Rizal’s life and activities while in France.
4. The Second Party agrees that the vlog’s content will be based from the said book and that it will contain snippets of historical information about Dr. Rizal’s activities in Frances, footages of places where Dr. Rizal stayed in France, and Dr. Rizal’s five (5) historical markers in France.

5. The Second Party agrees that the vlog will primarily use English with French subtitles. Filipino phrases can also be used to reach out to the Filipino community.
6. The First Party will provide suggestions to the Second Party's vlog, during the Second Party's initial submission of the one-minute teaser on June 16, 2021 and the vlog on June 18, 2021, prior to the June 19, 2021 posting of the Dr. Rizal Vlog on the First Party's social media account.
7. The Parties agree that all expenses relative to the materials necessary for Dr. Rizal Vlog shall be for the account of the Second Party.
8. The First Party shall review the content of the vlog before final release to ensure consistency with PH Embassy's views.
9. The First Party shall pay an honoraria in the amount of five hundred euros (500EUR) through a check to be issued in favor of the Second Party, which check shall be given after the Second Party has rendered the services required after this contract.
10. The Contract shall be effective upon signature of the Parties.
