**REQUIREMENTS FOR THE ISSUANCE
OF A TRAVEL DOCUMENT (TD)**

Additional documents may be required upon assessment of the application depending on the circumstances of the applicant.

1. Travel Document application form
2. Police report (only if lost passport)
3. Affidavit of Loss Passport or Affidavit of Explanation
4. Four (4) recent passport-sized photos
5. Copy of Philippine passport, if available
6. Proof of identity (valid IDs)
7. Fee: 49.50 Euros
8. Copy of tentative flight ticket

IMPORTANT:

- TD is only **valid for 30 days** from receiving the complete requirements and payment
- TD can only be used **one-way to the Philippines**
- **Some Airlines does not accept TD**, so please verify with your Airlines if they accept TDs


