BAC RESOLUTION NO. 07-2025

**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO ALLIANZ
FOR THE ONE-YEAR COMPREHENSIVE MOTOR VEHICLE INSURANCE
COVERAGE FOR THE PHILIPPINE EMBASSY'S NEW SERVICE VEHICLE**

WHEREAS, a motor vehicle insurance coverage is required by the Philippine Embassy for its newly procured service vehicle, FORD TOURNEO CUSTOM;

WHEREAS, on 11 March 2025, the Embassy posted, on its official website, a Request for Quotation (RFQ) for the procurement of a comprehensive motor vehicle insurance with one (1) year coverage for the Embassy's new service vehicle;

WHEREAS, the Embassy received the sole proposal submitted by Allianz with a total amount of Two Thousand Three Hundred Twelve and 30/100 (2,312.30 EUR) (or 122,232.38 PHP) for the one-year comprehensive motor vehicle insurance coverage (copy enclosed);

WHEREAS, payment for the abovementioned insurance coverage is included in the Philippine Embassy's 2025 Annual Procurement Plan (APP) with an Approved Budget for the Contract (ABC) of 150,000.00 PHP;

WHEREAS, GPPB Resolution No. 28-2017 dated 31 July 2017 (*"Approving the guidelines for the procurement of goods and services, infrastructure projects, and consulting services to be procured and performed overseas"*), currently governs procurement activities overseas. According to Annex A(4)(c) of GPPB Resolution No. 28-2017, receipt of at least one (1) quotation on the deadline for submission thereof shall be sufficient to proceed with its evaluation;

WHEREAS, ALLIANZ possesses the qualifications required under the provisions of GPPB Resolution No. 28-2017, and the proposal received from ALLIANZ is determined to be the single calculated and responsive bid;

NOW THEREFORE, premises considered, the Bids and Awards Committee hereby resolves to recommend to the Head of the Procuring Entity, the award of contract to **ALLIANZ** of a one-year comprehensive motor vehicle insurance coverage for its new service vehicle.
