**RESOLUTION RECOMMENDING THE RENEWAL OF CONTRACT WITH ALC
GLOBAL HEALTH INSURANCE FOR THE PROVISION OF THREE MONTHS
MEDICAL AND DENTAL INSURANCE PLAN FOR THE CONFIDENTIAL AND
CO-TERMINUS LOCAL HIRE (CCLH) OF THE EMBASSY**

WHEREAS, the current health insurance of Ms. Annie Rose Mabuti, Confidential Secretary and Co-terminus Local Hire (CCLH), will end on 31 March 2025.

WHEREAS, in compliance with Section 5 (Salary and required Salary Deductions) of Ms. Mabuti's Employment Contract states that *"6. The First Party shall provide the Second Party with an insurance plan that provides ample coverage for the medical and dental needs of the Second Party including the repatriation of mortal remains."*

WHEREAS, payment for abovementioned insurance requirement is included in the Philippine Embassy's 2025 Annual Procurement Plan with an Approved Budget for the Contract (ABC) of 132,000.00 PHP;

WHEREAS, GPPB Resolution No. 28-2017 dated 31 July 2017 (*"Approving the guidelines for the procurement of goods and services, infrastructure projects, and consulting services to be procured and performed overseas"*), currently governs procurement activities overseas. According to Annex A(4)(c) of GPPB Resolution No. 28-2017, receipt of at least one (1) quotation on the deadline for submission thereof shall be sufficient to proceed with its evaluation;

WHEREAS, ALC Global Health Insurance possesses the qualifications required under the provisions of GPPB Resolution No. 28-2017, and the proposal received from ALC Global Health Insurance with total amount of 608.76 EUR is determined to be the lowest calculated and responsive bid;

NOW THEREFORE, premises considered, the Bids and Awards Committee hereby resolves to recommend, and it hereby recommends to the Head of the Procuring Entity, that the procurement for a one-year medical and dental insurance plan for the confidential and co-terminus local hire (CCLC) be awarded to **ALC Global Health Insurance**.
