REQUIREMENTS FOR APPLICATION FOR
MARRIAGE BETWEEN FILIPINOS

PLEASE READ THE INSTRUCTIONS CAREFULLY.

1. **ORIGINAL AND ONE (1) PHOTOCOPY of PSA-ISSUED AND DFA AUTHENTICATED BIRTH CERTIFICATE** (with DFA seal and red ribbon) of both parties.

2. **ORIGINAL AND ONE (1) PHOTOCOPY of PSA-ISSUED AND DFA AUTHENTICATED CERTIFICATE OF NO MARRIAGE RECORD OR CENOMAR** of both parties. This document should be valid until the scheduled date of marriage at the Embassy.

If one or both parties were previously married, submit **ORIGINAL AND ONE (1) PHOTOCOPY OF PSA-ISSUED AND DFA AUTHENTICATED MARRIAGE CERTIFICATE WITH ANNOTATION OF JUDICIAL DECLARATION OF ANNULMENT OR VOID AB INITIO OR FOREIGN DIVORCE RECOGNIZED BY A PHILIPPINE COURT.**

If one or both parties is/are a widow(er), submit **ORIGINAL AND ONE (1) PHOTOCOPY OF PSA-ISSUED AND DFA AUTHENTICATED DEATH CERTIFICATE OF PREVIOUS SPOUSE.**

3. **AFFIDAVIT OF PARENTAL CONSENT** executed by parents of applicants aged 18 to 21 years old. If both parents are deceased, the Affidavit of Parental Consent shall be executed by the applicant's guardian, or by the person having legal charge over the applicant.

4. **AFFIDAVIT OF PARENTAL ADVICE** executed by the parents of applicants aged 22 to 25. If both parents are deceased, the Affidavit of Parental Advice shall be executed by the applicant's guardian, or by the person having legal charge over the applicant. If the Affidavit cannot be obtained for any reason, the Marriage License will be issued to the parties only when the following requirements are met:

- a) The lapse of three (3) months from the date the request for Parental Advice is made; AND
- b) Submission of ANY of the following:
 - i. The unfavourable written Parental Advice given by the parents or guardian; or
 - ii. A sworn statement indicating that the parents or guardian refused to give any Parental Advice.

Once the **AFFIDAVIT OF PARENTAL ADVICE** is obtained, it should go through the following notarial procedures:

- a) Notarization by a notary public
- b) Authentication by the Regional Trial Court of the area where the Affidavit was executed
- c) Authentication by the Department of Foreign Affairs in Manila (please refer to the address stated above)

5. **One (1) recent passport-size photo** for each of the applicants showing full frontal view

6. **Four (4) photocopies of each of the data page with signature of the applicants' passports**

7. **APPLICATION FOR MARRIAGE LICENSE and AFFIDAVIT** to be accomplished by **each** party

8. Payment of Fees:

- €45 for the Application for Marriage License filed by both parties, and
- €54 for the Solemnization of the marriage inside the Embassy premises

9. **PUBLICATION OF WEDDING BANNS** – Once all requirements are complied with, an announcement of the forthcoming wedding of the parties will be posted in conspicuous areas of the Philippine Embassy's Consular Section for **ten (10) consecutive days**. When the publication period ends and there are no objections to the marriage, the Consular Section will then schedule the date of the wedding.

10. The **MARRIAGE LICENSE** issued by the Embassy is valid for a period of **120 days** starting from the date of issuance.
